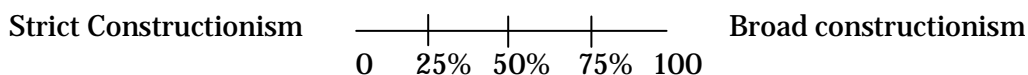

7. Describe your professional career and list the areas of law you have practiced and are currently practicing. Current employment? Have you been a judge? If so what type of cases?

11. Have you ever been investigated, disciplined, or reprimanded for conduct as a judge or lawyer? If so, please explain.

13. Please identify the U.S. Supreme Court Justice (current or past) who most reflects your judicial philosophy.
14. Please name a modern day former U. S. President who best represents your political philosophy.

15. Please identify one Supreme Court decision in your opinion which most impacted American society. Please explain.
16. Should judicial decisions be guided by the Natural and Moral law informed by the teachings found in Holy Scripture or by positive law when conflicts arise between moral and positive law? (Positive law as defined as enacted law—the codes, statutes, and regulations applied and enforced in the courts.) Please explain.
17. Do you believe students should be given all the information (theories and positions) about creation including intelligent design?
18. Free enterprise and private property rights turn man's natural self interest into the fairest and most productive economic system, the key to national prosperity. Do you agree? Please explain.
19. Briefly list one or two political issues of most concern to you, and explain why each is important to you.
20. Where would you place yourself as a jurist on a scale between strict and broad constructionism? Please explain.



**Definitions:**

**Strict Constructionism:** Interpreting the U.S. Constitution based on a literal and narrow definition of the language without reference to the differences in conditions when the Constitution was written and modern conditions, inventions and societal changes.

**Broad Constructionism:** A broad interpretation of the U.S. Constitution legitimately influenced by the contemporary needs of the nation and the spirit of the times; "broad, and often vague language, of the U.S. Constitution requires governmental or judicial interpretation using the current facts and issues".
